Furthermore, in consideration of Bearden Rugby Booster Club and Smoky Mountain Athletic Club allowing me to participate in this activity, I do agree to and hereby do forever release from fault, discharge, hold harmless and indemnify Tennessee Rugby Park against loss (including reasonable attorneys' fees) from any and all claims of ordinary negligence, demands, rights, or causes of action of any kind or nature that may hereafter at any time be made or brought by me or on my behalf, or by reason of any and all known or unknown, foreseen and unforeseen bodily or personal injuries in connection with the activity, except such liability or claim of liability as may result from the gross or intentional negligence on part of the Bearden Rugby Booster Club, Smoky Mountain Athletic Club, and Tennessee Rugby Park. Furthermore, I agree to indemnify Bearden Rugby Booster Club, Smoky Mountain Athletic Club, and Tennessee Rugby Park for any loss or damage to the premises, facility, or equipment of the Tennessee Rugby Park caused by me.
